Procedure

- **Step 1** Go to https://tools.cisco.com/bugsearch/.
- **Step 2** Log in with your Cisco account credentials.
- Step 3 Click Select from list > Security > Email Security > Cisco Secure Email Gateway, and click OK.
- **Step 4** In Releases field, enter the version of the release, for example, 14.0.2
- **Step 5** Depending on your requirements, do one of the following:
 - To view the list of resolved issues, select Fixed in these Releases from the Show Bugs drop down.
 - To view the list of known issues, select **Affecting these Releases** from the Show Bugs drop down and select **Open** from the Status drop down.



If you have questions or problems, click the **Help** or **Feedback** links at the top right side of the tool. There is also an interactive tour; to view it, click the link in the orange bar above the search fields.
