Dojo's "dual licensing" is different than that of many Open Source projects in that the terms of both licenses are Open Source and extremely permissive. There are no royalties or commercial use clauses to complicate things. In almost every case, you will not need to choose anything other than the AFL and in the common case you need not do anything to denote this choice of license. Many people and organizations are more familiar with the BSD license, and we encourage those people to use Dojo under those terms if it suits them better. A. HISTORY OF THE SOFTWARE
