THIS AMENDMENT NUMBER 2 ("Amendment #2) is entered into by and between the State of Alaska ("State") and Cisco Systems, Inc. ("Contractor").

WHEREAS, the State of Utah has a Master Agreement with the Contractor identified as Number AR233 effective June 1, 2014 through May 31, 2019, for Data Communications Products and Services (14-19);

WHEREAS, the parties hereto executed a Participating Addendum under the said Master Agreement, Participating Addendum State Contract Number 2014-DATACOM-0001, dated June 3, 2014 ("PA); and

WHEREAS, the terms of the Participating Addendum specifically state that the contract may be amended per agreement by both parties.

The parties agree to delete Section 2 of the PA. Participation, in its entirety and replace as follows:

Use of specific WSCA-NASPO cooperative contracts by agencies, political subdivisions and other entities (including cooperatives) authorized by an individual state's statutes to use state contracts are subject to the prior approval of the respective State Chief Procurement Official. Issues of interpretation and eligibility for participation are solely within the authority of the State Chief Procurement Official.

The State of Alaska is a WSCA Member State. The Department of Administration, Division of General Services, has the authority to sign WSCA Participating Addendums.

This Participating Addendum is hereby signed on behalf of the State of Alaska, for all state agencies and all political subdivisions. Entities entitled to make purchases under this Agreement include, but not limited to, Executive Branch agencies, University of Alaska, cities, towns, boroughs, municipalities or any subdivisions of municipalities within the state.

All other terms and conditions of this PA remain unchanged and in full force and effect.
