

End-of-Sale and End-of-Life Announcement for the Cisco Meeting Server 1000

EOL12676 - Amended

Cisco announces the end-of-sale and end-of-life dates for the Cisco Meeting Server 1000. The last day to order the affected product(s) is March 1, 2019. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.

The Original CMS 1000 was based upon a UCS C220 M4 server which has been superseded by the UCS C220 M5 server. Therefore, the CMS 1000 is being superseded by the CMS 1000 M5 (CTI-CMS1KM5-BUN-K9).
