Cisco announces the end-of-sale and end-of-life dates for the Cisco ASR1000 Shared Port Adapters 1x10 SPA. The last day to order the affected product(s) is September 29, 2023. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin.
