Cisco announces the end-of-sale and end-of-life dates for the Cisco MDS 9700 40-Gbps 24-Port Fibre Channel over Ethernet Module. The last day to order the affected product(s) is December 21, 2020. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.
