Cisco announces the end-of-sale and end-of-life dates for the Cisco Catalyst 4500 Supervisor Engine 9E. The last day to order the affected product(s) is October 30, 2021. Last Ship Date: HW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	January 29, 2022
End of SW Maintenance Releases Date: HW	The last date that Cisco Engineering may release any final software maintenance releases or bug fixes. After this date, Cisco Engineering will no longer develop, repair, maintain, or test the product software.	October 30, 2022
End of Vulnerability/Security Support: HW	The last date that Cisco Engineering may release a planned maintenance release or scheduled software remedy for a security vulnerability issue.	October 31, 2026
End of Routine Failure Analysis Date: HW	The last-possible date a routine failure analysis may be performed to determine the cause of hardware product failure or defect.	October 30, 2022
End of New Service Attachment Date: HW	For equipment and software that is not covered by a service-and- support contract, this is the last date to order a new service-and- support contract or add the equipment and/or software to an existing service-and-support contract.	October 30, 2022
End of Service Contract Renewal Date: HW	The last date to extend or renew a service contract for the product.	January 28, 2026

Last Date of Support: HW	The last date to receive applicable service and support for the product as entitled by active service contracts or by warranty terms and conditions. After this date, all support services for the product are unavailable, and the product becomes obsolete.	October 31, 2026
