The Cisco Unified Survivable Remote Site Telephony (SRST) Version 12 offer is being withdrawn as it has been superseded. The newer license offer listed in Table 2, enables both version 12 and 14 SRST systems and should be considered for all new purchases. This bulletin is not an End-of-Sale announcement for any aspect of the SRST feature set for Cisco routers.
