TERMS AND CONDITIONS FOR USE, REPRODUCTION, AND DISTRIBUTION

This license, the Lesser General Public License, applies to some specially designated software packages typically libraries of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.

To protect your rights, we need to make restrictions that forbid distributors to deny you these rights or to ask you to surrender these rights. These restrictions translate to certain responsibilities for you if you distribute copies of the library or if you modify it.

For example, if you distribute copies of the library, whether gratis or for a fee, you must give the recipients all the rights that we gave you. To protect each distributor, we want to make it very clear that there is no warranty for the free library. Also, if the library is modified by someone else and passed on, the recipients should know that what they have is not the original version, so that the original author's reputation will not be affected by problems that might be introduced by others.

Finally, software patents pose a constant threat to the existence of any free program. We wish to make sure that a company cannot effectively restrict the users of a free program by obtaining a restrictive license from a patent holder. Therefore, we insist that any patent license obtained for a version of the library must be consistent with the full freedom of use specified in this license.

Most GNU software, including some libraries, is covered by the ordinary GNU General Public License. This license, the GNU Lesser General Public License, applies to certain designated libraries, and is quite different from the ordinary General Public License. We use this license for certain libraries in order to permit linking those libraries into non-free programs.

When a program is linked with a library, whether statically or using a shared library, the combination of the two is legally speaking a combined work, a derivative of the original library. We call this license the "Lesser" General Public License because it does Less to protect the user's freedom than the ordinary General Public License. 0. A "library" means a collection of software functions and/or data prepared so as to be conveniently linked with application programs (which use some of those functions and data) to form executables.

A “work based on the Library” means either the Library or any derivative work under copyright law: that is to say, a work containing the Library or a portion of it, either verbatim or with modifications and/or translated straightforwardly into another language. If, as a consequence of a court judgment or allegation of patent infringement or for any other reason (not limited to patent issues), conditions are imposed on you (whether by court order, agreement or otherwise) that contradict the conditions of this License, they do not excuse you from the conditions of this License. If you cannot distribute so as to satisfy simultaneously your obligations under this License and any other pertinent obligations, then as a consequence you may not distribute the Library at all. In such case, this License incorporates the limitation as if written in the body of this License.

13. The Free Software Foundation may publish revised and/or new versions of the Lesser General Public License from time to time. Such new versions will be similar in spirit to the present version, but may differ in detail to address new problems or concerns.

For Unix: “./configure; make test; make install” For MSDOS, use one of the special makefiles such as `Makefile.msc`. For VMS, use `Make_vms.com` or `descrip.mms`.

The changes made in version 1.1.4 are documented in the file ChangeLog. The only changes made since 1.1.3 are bug corrections:

- ZFREE was repeated on same allocation on some error conditions.
This creates a security problem described in <http://zlib.net/advisory-2002-03-11.txt>.
- Returned incorrect error (Z_MEM_ERROR) on some invalid data.
- Avoid accesses before window for invalid distances with inflate window less than 32K.
- force windowBits > 8 to avoid a bug in the encoder for a window size of 256 bytes. (A complete fix will be available in 1.1.5).

The beta version 1.1.5beta includes many more changes. A new official version 1.1.5 will be released as soon as extensive testing has been completed on it.

Notes for some targets:

- To build a Windows DLL version, include in a DLL project zlib.def, zlib.rc and all .c files except example.c and minigzip.c; compile with -DZLIB_DLL The zlib DLL support was initially done by Alessandro Iacopetti and is now maintained by Gilles Vollant <info@winimage.com>. Check the zlib DLL home page at <http://www.winimage.com/zLibDll/index.html>.
From Visual Basic, you can call the DLL functions which do not take a structure as argument: compress, uncompress and all gz* functions. See contrib/visual-basic.txt for more information, or get the cmp-z-it.zip file from <http://www.winimage.com/zLibDll/index.html>.
- For 64-bit Irix, deflate.c must be compiled without any optimization.
With -O, one libpng test fails. The test works in 32 bit mode (with the -n32 compiler flag). The compiler bug has been reported to SGI.
- zlib doesn't work with gcc 2.6.3 on a DEC 3000/300LX under OSF/1 2.1 it works when compiled with cc.
- on Digital Unix 4.0D (formerly OSF/1) on AlphaServer, the cc option -std1 is necessary to get gzprintf working correctly. This is done by configure.
- zlib doesn't work on HP-UX 9.05 with some versions of /bin/cc. It works with other compilers. Use "make test" to check your compiler.
- gzopen is not supported on RISCOS, BEOS and by some Mac compilers.

- For Turbo C the small model is supported only with reduced performance to avoid any far allocation; it was tested with `-DMAX_WBITS=11 -DMAX_MEM_LEVEL=3`
- For PalmOs, see Per Harald Myrvang (perm@stud.cs.uit.no).
