## Audience and Use

The *Cisco Unity Bridge Installation Guide* is intended for installers of the Cisco Unity Bridge.

The *Cisco Unity Bridge Installation Guide* contains instructions for installing the Bridge, which acts as a networking gateway between Cisco Unity and an Avaya Octel system on an Octel analog network. You install the Bridge after the Cisco Unity system has been set up, and the Bridge must be installed on a separate and dedicated platform. You also need a working knowledge of Microsoft Windows 2000 Server.

The “[Overview of Mandatory Tasks for Installing the Cisco Unity Bridge](#)” chapter contains a high-level task list that references detailed instructions in the rest of the *Cisco Unity Bridge Installation Guide* and in other Bridge documentation. Follow the documentation to install the Bridge correctly.

## Definitions of Service Request Severity

To ensure that all service requests are reported in a standard format, Cisco has established severity definitions.

Severity 1 (S1)—Your network is “down,” or there is a critical impact to your business operations. You and Cisco will commit all necessary resources around the clock to resolve the situation.

Severity 2 (S2)—Operation of an existing network is severely degraded, or significant aspects of your business operation are negatively affected by inadequate performance of Cisco products. You and Cisco will commit full-time resources during normal business hours to resolve the situation.

Severity 3 (S3)—Operational performance of your network is impaired, but most business operations remain functional. You and Cisco will commit resources during normal business hours to restore service to satisfactory levels.

Severity 4 (S4)—You require information or assistance with Cisco product capabilities, installation, or configuration. There is little or no effect on your business operations.
