



## End-of-Sale and End-of-Life Announcement for the Cisco ONS 15600 Optical Cable and Optical Cable Consumables

Cisco Systems® announces the end-of-sale and end-of-life dates for the Cisco® ONS 15600 Optical Cable and Optical Cable Consumables. The last day to order the affected product is November 28, 2006. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) until November 27, 2011. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product. Table 2 lists the product part numbers affected by this announcement.

Customers will now be able to purchase LC standard optical cables and cleaning kits from companies other than Cisco. All fixed-port OGI IO modules are also end of sale/end of life and will not require the items identified in this product bulletin. End-of-Life Announcement Date	The date the document that announces the end of sale and end of life of a product is distributed to the general public.	May 30, 2006
End-of-Sale Date	The last date to order the product through Cisco point-of-sale mechanisms. The product is no longer for sale after this date.	November 28, 2006
Last Ship Date	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	February 26, 2007

Currently there are no customers required to trade in products in Table 2 above.
