

## End-of-Sale and End-of-Life Announcement for the Cisco BTS 10200 Specified Hardware

EOL5072 - Amended

Cisco announces the end-of-sale and end-of life dates for the Cisco<sup>®</sup> BTS 10200 Specified Hardware. The last day to order the affected product(s) is March 16, 2007. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available until the termination date of the contract, even if this date exceeds the Last Date of Support shown in Table 1.

The information in this Cisco BTS 10200 end-of-life/end-of-sale product bulletin is limited to Cisco direct and Cisco approved reseller purchases and is applicable only to the product part numbers in Table 2. For non Cisco purchases, please refer to the original equipment manufacturer's website for hardware service and support terms and conditions.
