

**Cisco "Passport Drawing" Sweepstakes
COMPLETE OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Void where prohibited by law. This sweepstakes begins at 5:30:00 PM Eastern Time ("ET") on June 30, 2008 and ends at 7:20:00 PM CT on July 30, 2008. ("Promotion Period")

1. **ELIGIBILITY:** The Cisco Networking Academy Conference "Passport Drawing" Sweepstakes ("Sweepstakes") is sponsored by Cisco Systems, Inc.
