I agree to hold the Filmmaker, his/her/their affiliates and any third parties harmless against any liability, loss or damage (including reasonable attorney's fees) caused by or arising out of or in connection with my appearance on the Video, whether or not caused by the negligence of the Filmmaker, including without limitation claims regarding intellectual property, defamation and invasion of privacy or publicity.
