Courthouses can go digital, significantly reducing expenses by replacing paper-based processes with electronic-based systems across the court, including back-office systems, data transfers (such as sentencing triggers, warrants, and DA summons), online database queries, Internet-based activities (such as online payments and juror disqualifications), e-receipts, e-filing, e-citation, and more. Shared court recording and reporting improves efficiency by remotely engaging recorders/reporters in any courtroom. Meanwhile, real-time, interactive video arraignments, sentencing, and remediation hearings eliminate the need to transport prisoners, minimizing both risk and cost, as well as scaling resources.
