Cisco announces the end-of-sale Cisco 350 Series Managed Switches. The last day to order the affected product(s) is January 29, 2023. Customers will continue to receive phone support from the Cisco Small Business Support Center (SBSC) as shown in Table 1 of the EoL bulletin. For customers with active product warranties, support will be available as stated in the product warranty terms and conditions.

End-of-Life Announcement Date	The date the document that announces the end-of-sale and end-of-life of a product is distributed to the general public.	July 30, 2022
End-of-Sale Date: HW	The last date to order the product through Cisco point-of-sale mechanisms. The product is no longer for sale after this date.	January 29, 2023
End of Phone Support: HW	The last date to receive phone support as part of the product warranty. After this date, all phone support services for the product are available with additional charges or support fees. In some cases, support may not be available.	January 29, 2024
Last Ship Date: HW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	April 29, 2023

While Cisco is committed to the End-of-sale milestone, based on the inventory and supply status, Cisco may need to turn off the orderability for SKUs before the End-of-sale date.
