

# End-of-Sale and End-of-Life Announcement for the Cisco Nexus 5500 Series Layer 3 Daughter Card and Module (V1) and 1100W Power Supply

Cisco announces the end-of-sale and end-of-life dates for the Cisco Nexus 5500 Series Layer 3 Daughter Card and Module (V1) and 1100W Power Supply. The last day to order the affected product(s) is April 30, 2017. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.
