Cisco announces the end-of-sale and end-of-life dates for the Cisco Nexus 7000 M2-Series 24-Port 10 Gigabit Ethernet Module with XL Option. The last day to order the affected product(s) is May 5, 2019. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Last Ship Date: HW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	August 4, 2019
