
## Acano X Series and licensing End-of-Sale (EoS) Announcement

Cisco acquired Acano in January 2016. As part of that acquisition, Cisco is announcing the end-of-sale of the Acano X-series servers and licensing PIDs. Key milestones, service and support information, and specific migration PIDs are shown in Tables 1 and 2.
