

End User License Agreements

IMPORTANT: PLEASE READ THESE END USER LICENSE AGREEMENTS CAREFULLY. **USE** OF THE TANDBERG CONTENT SERVER SUPPLIED BY TANDBERG TELECOM AS, OR ANY OF ITS AFFILIATES, DIRECTLY OR THROUGH ITS AUTHORIZED RESELLERS, ("TANDBERG"), WILL CONSTITUTE (i) YOUR ACKNOWLEDGEMENT OF RECEIPT OF THIS DOCUMENT AND (ii) YOUR **AGREEMENT** TO BE BOUND BY THE TERMS OF THE END USER LICENSE AGREEMENTS ("AGREEMENTS"). IF YOU DO NOT AGREE TO THE TERMS OF THESE AGREEMENTS, DO NOT INSTALL OR USE THE SERVER AND RETURN IT AND ALL RELATED DOCUMENTATION TO THE PLACE OF PURCHASE WITHIN TEN (10) DAYS FOR A FULL REFUND.

General End-User License Agreement

TANDBERG, or its licensors, owns all intellectual property rights, including patent, copyright, trade secret, trademark and other proprietary rights, in and to the Tandberg Content Server computer system ("System"), the software contained or used therein ("Software") (together the "Server") and the related documentation ("Documentation"). Your rights are limited to those expressly granted in this agreement and the related end user license agreements (the "Agreement"). The Agreement grants You a limited non-transferable and non-exclusive license to use, solely for Your internal business purposes, the Server and Documentation, as ordered and paid for by You and identified in the invoice for the Server, under the terms and conditions set forth herein.

You may:

- install the Server in the country and in the place intended by Your order for the Server ("Site");
- use the Server at the Site under the scope of license granted herein;
- permit third party service providers to utilize the Server at the Site on Your behalf within the scope of license granted herein and provided such third party service provider agrees to be bound by the terms and conditions of the Agreement; and
- copy and use the Documentation as reasonably necessary in connection with Your authorized use of the Server.

You may not:

- use or distribute the Software except as an integrated component of the Server;
- modify, adapt, decompile, disassemble, or reverse engineer the Software installed on the Server, except to the extent that the foregoing restriction is expressly prohibited by applicable law;
- create derivative works based on the Software;
- make unauthorized copies of the Software;
- allow any unauthorized third party to use or have access to the Server, the Software or Documentation;
- install on the Server any software other than upgrades supplied by TANDBERG or other software (i) explicitly allowed in the Documentation or (ii) recommended by authorized TANDBERG support engineers or partners;
- to the fullest extent permitted by law, use the Server as an add-in product to any third party product without TANDBERG's prior written consent;
- use, evaluate or view the Server, the Software or Documentation for the purpose of designing, modifying, or otherwise creating any software program, or any portion thereof, which performs functions similar to the functions performed by the Server; or

- without the prior written consent of TANDBERG, transfer or assign the Software or Your rights under this Agreement, including an assignment by operation of law.

You acknowledge and agree that:

- the Server, the Software and Documentation contain valuable proprietary information and trade secrets of TANDBERG and its licensors and You shall protect the secrecy of, and avoid disclosure and unauthorized use of, the Server, the Software or the Documentation, using at least those measures that You take to protect Your own most highly confidential information;
- You shall comply with all applicable export control laws and regulations with respect to the Server, the Software and Documentation;
- TANDBERG will not be liable for any loss (whether direct or indirect) of any data or business information of any kind, savings, profits, or business interruption, to the fullest extent allowed by applicable law and even if TANDBERG has been advised of the possibility of such damages;
- any violation or threatened violation of the Agreement may cause irreparable injury to TANDBERG for which injunctive relief may be appropriate, in addition to all legal remedies;
- upon violation of any of the provisions of the Agreement or the expiration of the term of Your license, Your rights to use the Server, the Software and Documentation shall automatically terminate and You shall return to TANDBERG or destroy all copies of the Server, the Software and Documentation; and
- TANDBERG'S licensors are third-party beneficiaries of this End-User License Agreement.

U.S. GOVERNMENT. All software provided to the United States government pursuant to solicitations issued on or after December 1, 1995 is provided with the commercial license right and restrictions described herein.

TANDBERG will not be responsible for any failure to perform due to "force majeure" causes beyond its reasonable control including, but not limited to, acts of God, riots, embargoes, terrorist acts, acts of civil or military authorities, disruptions in the flow of data to or from networks, denial of or delays in processing of export license applications, accidents, strikes, fuel crises or power outages.
