All references to End User in the support documentation and SLA mean You and do not include COP Partners. COP Partners are entities that Cisco authorizes to build code, user experiences, or solution packages that function as add-ons to or otherwise enhance an existing COP Application ("**Module(s)**").

2. Support and Other Services

- 2.1 End User Support. Your purchase of the Product includes Enterprise Support.
- 2.2 **COP Partner Support**. For COP Partners, Cisco will use commercially reasonable efforts to provide support for the Product as outlined in the COP Partner Program Terms. This support is distinct from the support that Cisco provides to end users of the Product.
- 2.3 **COP Application and Module Prerequisites**. You may purchase select applications that run on the Product ("**COP Application(s)**") and Modules as an optional add-on. Use of COP Applications requires an active license for the Product and use of the Modules requires active licenses for both the Product and the applicable COP Application. In addition to the terms of the Agreement, end users are also subject to any terms applicable to the Module(s) they use, whether those are supplemental Cisco terms or the respective COP Partner terms.
