Outshift QRNG or Quantum Random Number Generator (the “**Product**”) is an online platform that provides users the ability to access random numbers, in the user’s selected format (binary, hexadecimal, decimal and octal), which have been pre-generated using randomness derived from quantum mechanics. The Product includes an API and related key, which allows users to access the platform and explore features such as unpredictability in a testing scenario, as more fully described in the Documentation available at <https://api.qrng.outshift.com/docs>. Your use of the Product is limited to testing and demonstration purposes only.

Your use of the Product via the API is subject to the following limits: You may retrieve up to 100,000 bits worth of numbers per day per registered user, with a maximum of 10,000 bits per number, and up to 1,000 numbers per API call. You are responsible for maintaining the security of Your API key and for all activity that occurs under Your API credentials.
