Valtix is a multi-cloud network security platform delivered as a service. It decouples the control and data plane, resulting in two components - the Valtix Controller and the Valtix Gateway. The Valtix Controller provides the management and control plane. It also deploys the Valtix Gateway, a Platform-as-a-Service (PaaS) used in the customer's public cloud account(s) to provide advanced, inline security protections to defend against external attacks, prevent egress data exfiltration and prevent the lateral movement of attacks.

The Product is available in four tiers, and each tier includes the entitlements and is subject to the limitations described in <u>Pricing Tiers and Entitlements</u>.
