2.3 Additional Product Terms

- (A) The Cisco SMI Software is required to run the remainder of the Cisco Offer. You may use the SMI Software purchased as part of the Cisco Offer solely to run the other Software products included in the Cisco Offer.
- (B) For purposes of the Software in the Cisco Offer, (1) a Unique User is equivalent to a broadband subscriber and (2) Bandwidth is equivalent to the number of downstream DOCSIS (Data Over Cable Service Interface Specification) frequency segments (also referred to as "channels") used to transmit downstream broadband data at varying speeds between a device and a Unique User.
- (C) If the applicable Entitlement or Documentation identifies a specific DOCSIS version (for example, DOCSIS 3.0 or 3.1), then You can only use Your license with such DOCSIS version(s).
