2. ThousandEyes True Forward

Quarterly True Forward for Exceptional Growth for ThousandEyes Suites

At Cisco’s quarterly True Forward review, if Your average monthly use in the quarterly period exceeds 115% of Your then-current Entitlement, Cisco has the right to (1) issue a True Forward invoice to Your Approved Source for the average monthly consumption that is above Your then-current Entitlement, for the remainder of the Suite Term and (2) increase Your monthly Entitlement to the increased monthly use. For calculation of Cisco’s quarterly True Forward review, if Your actual monthly use in any given month is less than Your monthly Entitlement, You will be deemed to have used an amount equal to Your monthly Entitlement in such month.

Annual True Forward for ThousandEyes Suites

At Cisco’s annual True Forward, if Your average monthly use during the prior year exceeds Your then-current monthly Entitlement, Cisco has the right to (1) issue a True Forward invoice to Your Approved Source for the average monthly consumption that is above the then-current monthly Entitlement, for the remainder of the Suite Term and (2) increase Your monthly Entitlement to the increased monthly use. For calculation of Cisco’s

True Forward review, if Your actual monthly use in any given month is less than Your monthly Entitlement, You will be deemed to have used an amount equal to Your monthly Entitlement in such month.

Exceptions to the True Forward

Increasing use of Cisco ThousandEyes Endpoint Agents, ThousandEyes Subscription Services, ThousandEyes National Subscription Services, or Internet Insights by any amount requires a change in Your subscription.
