Overview

End of Sale (EOS) for Business Critical Services 2.3

In January 2021, Cisco announced the end-of-sale dates of the Business Critical Services 2.3 SKU's globally. BCS 2.x quotes not booked by January 31st, 2023 will no longer be valid and thus become non-orderable. This notice is to serve as a reminder to our community of Services Sales Specialists, Renewals Specialists, Business Development Managers, and DAT experts. Please work with your Business Development Manager for assistance renewing of your customer's Master Sales Agreement.

Customers with active service contracts will continue to receive support until the termination date of their contract. BCS 2.x orders can be approved only if they meet the following criteria:

- 1. Renewal of existing customer multi-year contractual agreement:
 - Please ensure the current version of the MSA includes addendum dictating customer to renew to 2.x terms.
- 2. Combined Services true-up on an existing 2.x contracts:
 - For Combined Services true-up with BCS 2.x, a corresponding quote is required for booking.
- 3. Federal customers:
 - Federal customer with existing BCS 2.x contract with 2.x SKUs that are approved and "locked."

Business Critical Services 2.3 SKU's will be replaced by the Business Critical Services 3.0 offer with cross architecture SKUs. Sellers are advised to begin positioning Business Critical Services 3.0 SKUs with their customers effective immediately. This will allow for increased offer standardization and also help deliver Business Critical Services with greater flexibility.

Sellers are advised to begin positioning Business Critical Services 3.0 SKUs with their customers effective immediately. This will allow for increased offer standardization and also help deliver Business Critical Services with greater flexibility.
