



Supplemental End User License Agreement

IMPORTANT: READ CAREFULLY

Dear Customer,

This Supplemental End User License Agreement ("SEULA") contains additional terms and conditions for the Software licensed under the End User License Agreement ("EULA") between you and Cisco (collectively, the "Agreement"). Capitalized terms used in this SEULA but not defined will have the meanings assigned to them in the EULA. To the extent that there is a conflict between the terms and conditions of the EULA and this SEULA, the terms and conditions of this SEULA will take precedence.

In addition to the limitations set forth in the EULA on your access and use of the Software, you agree to comply at all times with the terms and conditions provided in this SEULA. DOWNLOADING, INSTALLING, OR USING THE SOFTWARE CONSTITUTES ACCEPTANCE OF THE AGREEMENT, AND YOU ARE BINDING YOURSELF AND THE BUSINESS ENTITY THAT YOU REPRESENT (COLLECTIVELY, "CUSTOMER") TO THE AGREEMENT. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THE AGREEMENT, THEN CISCO IS UNWILLING TO LICENSE THE SOFTWARE TO YOU AND (A) YOU MAY NOT DOWNLOAD, INSTALL OR USE THE SOFTWARE, AND (B) YOU MAY RETURN THE SOFTWARE (INCLUDING ANY UNOPENED CD PACKAGE AND ANY WRITTEN MATERIALS) FOR A FULL REFUND, OR, IF THE SOFTWARE AND WRITTEN MATERIALS ARE SUPPLIED AS PART OF ANOTHER PRODUCT, YOU MAY RETURN THE ENTIRE PRODUCT FOR A FULL REFUND. YOUR RIGHT TO RETURN AND REFUND EXPIRES 30 DAYS AFTER PURCHASE FROM CISCO OR AN AUTHORIZED CISCO RESELLER, AND APPLIES ONLY IF YOU ARE THE ORIGINAL END USER PURCHASER.

Definitions

"Demo Version" means a performance constrained version of the Software that is licensed by Cisco to end users solely for internal use in a non-production environment for demonstration and evaluation purposes.

"Instance" means a single copy of the Software. Each copy of the Software loaded into memory constitutes a single Instance.

"License Term" means the period of time during which Customer is authorized by Cisco to use the Software. Such period of time will be indicated in the description associated with the Cisco product identification number for the applicable Software license purchased by Customer from an Approved Source.

"Production Version" means a version of the Software that is licensed by Cisco to end users for internal use in a production environment.

"Simulation Version" means a performance constrained version of the Software that is licensed by Cisco to end users solely for internal use in a non-production environment for purposes of simulating Cisco IOS-XR based networks.

"Software" means the Cisco IOS-XRv software.

"Version" means the Demo Version, Production Version or Simulation Version, as applicable.

"Virtual Machine" means a software implementation of a machine (i.e., a computer) that executes programs like a physical machine.

Additional License Terms and Conditions

1. Conditioned upon compliance with the terms and conditions of the Agreement, Cisco hereby grants to Customer a nonexclusive and nontransferable right to install and use a single Instance of the applicable Version of the Software solely during the License Term for which Customer has paid the required license fees to an Approved Source.
2. Customer is permitted to deploy the Software solely on a Virtual Machine; provided, however, each Instance of the Software requires payment of the applicable license fees by Customer to an Approved Source.
3. If Customer purchased a license for the Demo Version, Customer is permitted to use the Demo Version solely for internal use in a non-production environment for demonstration and evaluation purposes.
4. If Customer purchased a license for the Simulation Version, Customer is permitted to use the Simulation Version solely for internal use in a non-production environment for purposes of simulating Cisco IOS-XR based networks.
5. If Customer purchased a license for the Production Version, Customer is permitted to use the Production Version in a production environment.
6. Customer acknowledges and agrees that a license for a Version cannot be extended and cannot be converted into a license for another Version and that a new separate license will need to be purchased for any such Version. For example, if Customer purchased a license for the Simulation Version and Customer desires to use the Software for production purposes, Customer needs to purchase a new separate license for each Instance of the Production Version.
7. Upon termination or expiration of the License Term, Customer shall cease all use of the Software and Customer shall destroy all copies of Software in its possession or control.

Description of Other Rights, Obligations and Terms

1. The Software is based on Cisco's IOS-XR software product. However, the Software and Cisco's IOS-XR software are separate products. The Software does not have the same features, functionality or performance as Cisco's IOS-XR software. Please see the Software's Documentation for a description of the Software
