A. HISTORY OF THE SOFTWARE

contextlib2 is a derivative of the contextlib module distributed by the PSF as part of the Python standard library. According, it is itself redistributed under the PSF license (reproduced in full below). As the contextlib module was added only in Python 2.5, the licenses for earlier Python versions are not applicable and have not been included.

Python was created in the early 1990s by Guido van Rossum at Stichting Mathematisch Centrum (CWI, see <http://www.cwi.nl>) in the Netherlands as a successor of a language called ABC. Guido remains Python's principal author, although it includes many contributions from others.

Preamble

When we speak of free software, we are referring to freedom of use, not price. Python was created in the early 1990s by Guido van Rossum at Stichting Mathematisch Centrum (CWI, see <http://www.cwi.nl>) in the Netherlands as a successor of a language called ABC. Guido remains Python's principal author, although it includes many contributions from others.

In 1995, Guido continued his work on Python at the Corporation for National Research Initiatives (CNRI, see <http://www.cnri.reston.va.us>) in Reston, Virginia where he released several versions of the software.
