



LICENSE AGREEMENT FOR DISPLAY OF NAME AND LOGO

This License Agreement for Display of Name and Logo ("Agreement") is between the Procurement Professionals Alliance, an Arizona-based non-profit whose primary place of business is c/o The Works – Gilbert, 1525 S. Higley Road, Suite 104, Gilbert, AZ 85296 ("PPA") and Cisco Systems, Inc. located at 170 West Tasman Dr. San Jose, CA 95134 ("Licensee").

PPA and Licensee agree as follows:

1. **Pre-existing Intellectual Property.** PPA retains all rights, title, and interest in its own pre-existing intellectual property, and any derivative thereof, including all trademark, copyrights, images, logos, and other branding.
2. **License Grant.** PPA grants to Licensee, its subcontractors, resellers, and agents ("Licensee Parties") a nonexclusive, limited, and revocable license to display the RFXPremier name and the following PPA logo ("Licensed Materials"):
 - a. RFXPremier Supplier Partner logo
 - b. RFXPremier Supplier Partner Affiliate logo
3. **Term of Agreement.**
 - a. The term of this license runs concurrent with the term of Master Agreement #**SPSD26-0563LS_CIS**, held by Licensee for Data Communications, and any extension thereto ("Master Agreement").
 - b. At any time, PPA may revoke Licensee's license to display the Licensed Materials. PPA must do so in writing and provide notice to Licensee.
 - c. Upon notice of revocation or upon expiration of the Master Agreement, Licensee must cease all use of the Licensed Materials within thirty (30) calendar days, except that Licensee may use the RFXPremier name for reference purposes in a description of its prior experience.
4. **Permitted Use.** Licensee Parties may display the Licensed Materials only as set forth below.
 - a. Licensee Parties must display the Licensed Materials consistent with the attached RFXPremier Supplier Partner and Supplier Partner Affiliate Logo Style Guide and any revisions thereto.
 - b. Licensee Parties may display the Licensed Materials solely to advertise the Master Agreement in publications and promotional materials aimed at state, local government, and other entities eligible to use the Master Agreement which includes displaying the RFXPremier name and Licensed Materials on the face of any Master Agreement, including electronic and hard copy versions and on a web site as a "click on" link to the Master Agreement.
5. **Prohibited Use.** Any use not expressly permitted in this Agreement is prohibited. Additionally:
 - a. Licensee Parties shall not make explicit or implicit representations concerning the opinion of PPA, RFXPremier, the Lead Entity, or any Participating Entity regarding Licensee or its products or services.
 - b. Licensee Parties shall not use the Licensed Materials in any way that indicated it has ownership or control of PPA or its brand.
 - c. Licensee Parties shall not use the RFXPremier name or Licensed Materials in any manner or context that could adversely affect, harm, or diminish PPA's integrity, goodwill, sales, or

reputation.

General Provisions.

- a. Licensee shall ensure that its subcontractors, resellers, and agents adhere to the terms of this Agreement, and Licensee is responsible for any breach by these entities.
- b. In the event of a dispute, any claim or cause of action arising from this Agreement must be brought in a state or federal court of competent jurisdiction in the State of Arizona.
- c. This Agreement is the complete and final agreement between PPA and Licensee related to the use or display of Licensed Materials, names, and logos, and supersedes any prior or contemporaneous Agreement, whether granted by PPA or one of its predecessors.

PPA and Licensee accept the terms of this Agreement as per the dates and signatures set forth below.
