



Quick Reference: Comparison Between Cisco Certified Refurbished Equipment, New Cisco Equipment, and Cisco Equipment from Unauthorized Sources

While your intent should always be to sell new Cisco® equipment first, there are some situations in which new equipment is not an option. In these cases, genuine Cisco Certified Refurbished Equipment from Cisco is the most reliable alternative for your customer.
