As a Cisco Software User -



what are you authorized to do

- You are granted by Cisco a limited, non-exclusive and non-transferable license to use object code versions of the Cisco software solely for your internal operations and in accordance with the licensing terms and the documentation
- The right to use the software applies only to Cisco software procured from approved source (Cisco or the Cisco authorized reseller, distributor or systems integrator from whom you acquired the Cisco software) unless stated otherwise by applicable law. If you are interested in transfer of Cisco software license, please refer to Cisco software transfer and re-licensing policy here: www.cisco.com/go/eula
- You may permit a third party to use the Cisco software licensed to you under the EULA if such use is solely a) on your behalf, b) for your internal operations, and c) in compliance with the EULA



what you are not authorized to do

- Transfer, sublicense or assign rights under the EULA to any other person or entity unless expressly authorized by Cisco in writing or permitted under the applicable law
- Modify, adapt or create derivative works of the Cisco software or documentation
- Reverse engineer, decompile, decrypt, disassemble or otherwise attempt to derive the source code for Cisco software, unless expressly authorized by Cisco in writing, and to the extent defined by applicable law
- Make the functionality of the Cisco software available to third parties, whether as an application service provider, or on a rental, service bureau, cloud service, hosted service, or other similar basis unless expressly authorized by Cisco in writing
- Use the Cisco software on a device other than originally intended for, unless expressly authorized by Cisco in writing
- Remove or modify any product information, copyright or other proprietary and intellectual property notices or other marks on or within the Cisco software

As a Cisco software user, what are your other obligations?

Any update, upgrade and copies of Cisco software have to be conducted in compliance with EULA terms.

User of Cisco software has obligation during the license term and for **three years** after its expiration to keep records regarding use of the software. The user has to allow Cisco and its auditors to review at user's premises the records of the software use. Underpayment of license fees including reasonable audit costs will have to be paid to Cisco within 30 days of written notice.

You are not licensed to use the Cisco software on **secondhand** or **refurbished Cisco equipment not authorized by Cisco**, or on Cisco equipment not purchased through an approved source, unless expressly permitted under the applicable law.
