- Improve customer satisfaction by enabling mobile worker availability wherever they are and maintaining customer service during a crisis.
- Lower mobility costs using cost-effective alternatives, such as reducing roaming and toll charges by placing and receiving calls over the Internet or your corporate wireless network.
- Help employees maintain work/life balance by providing flexible working options and improving workforce recruitment, retention and satisfaction.

Statistics & Proof Points

- According to the latest Census numbers, 4.5% of Americans, or about 6.5 million people, are working from home most of the time. That's up from 3.2% in 2000, and roughly double the proportion in 1980.¹
- In the United States, those who spend up to 20% of their time working remotely are the most engaged of all workers surveyed.²
- 6.1 million individuals in the U.S. can be categorized as remote workers.³
- Nearly 4 out of 10 companies currently allow some employees to work remotely.⁴
- 49% of respondents telecommute at least once a week.⁵
- 82% of telecommuters reported lower stress levels.⁶
- 80% of workers reported higher morale when working from home, while 69% reported lower absenteeism.⁷
- Offering remote work options reduced employee turnover, and “job attrition rates fell by over 50%”.⁸
- Bureau of Labor Statistics data shows that in 2015, 23% of employees reported doing some of their work remotely, up from 19% in 2003.⁹
- Worldwide, more than 50% of people who telecommute part-time said they wanted to increase their remote hours. Additionally, 79% of knowledge workers said they work from home, and 60% of remote workers said that if they could, they would leave their current job for a full-time remote position at the same pay rate.¹⁰
