

End-of-Sale and End-of-Life Announcement for the Cisco CSS 11501 Content Services Switch with SSL, and the Cisco CSS 11500 SSL Module

EOL4031 - Amended

Cisco announces the end-of-sale and end-of life dates for the Cisco CSS 11501 Content Services Switch with SSL, and the Cisco CSS 11500 SSL Module. The last day to order the affected product(s) is November 8, 2006. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available until the termination date of the contract, even if this date exceeds the Last Date of Support shown in Table 1.

Customers are encouraged to migrate to the Cisco CSS 11501 Switch with integrated SSL termination and HTTP compression and the Cisco CSS 11500 SSL Module with HTTP compression. These two new products deliver higher SSL performance and can support HTTP compression. Table 2 provides relevant information for migrating to the replacement product.
