Cisco announces the end-of-sale and end-of-life dates for the Cisco Business Dashboard Licenses. The last day to order the affected product(s) is February 10, 2026. The last day to renew or add to an existing subscription is February 10, 2026. Customers with active service contracts and subscriptions (as applicable) will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts and subscriptions (as applicable), support will be available under the terms and conditions of customers' service contract and subscription.

Licensing Update: Effective with Cisco Business Dashboard version 2.11.1 (releasing in February 2026), paid licenses are no longer required to manage more than 25 network devices. This update simplifies your deployment by removing the need for license procurement for core management features, regardless of your network size. Please be advised that while the licensing SKUs for Cisco Business Dashboard have reached their End-of-Sale milestone and are being retired, the dashboard itself remains fully available. End-of-Life Announcement Date	The date the document that announces the end-of-sale and end-of-life of a product is distributed to the general public.	February 10, 2026
End-of-Sale Date*	The last date to order the product through Cisco point-of-sale mechanisms. The product is no longer for sale after this date.	February 10, 2026
End of Change/Renewal Date* Subscription	The last date to Renew or Add to an existing subscription.	February 10, 2026
Last Date of Support** Subscription	The last date to receive applicable subscription entitlements, service and support for the product as entitled by active subscriptions and service contracts(as applicable) or by warranty terms and conditions. After this date, all subscription and support services for the product are unavailable, and the product becomes obsolete.	January 31, 2027
