Cisco announces the end-of-sale and end-of-life dates for the Cisco Prime Cable Provisioning 5.0, 5.1, 5.2, and Miscellaneous PIDs. The last day to order the affected product(s) is April 17, 2018. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.
