



## End-of-Sale and End-of-Life Announcement for the Cisco Prime Central 1.0

Cisco announces the end-of-sale and end-of-life dates for the Cisco Prime Central 1.0. The last day to order the affected product(s) is April 1, 2013. For customers with active and paid service and support contracts, support will be available until the termination date of the contract, even if this date exceeds the Last Date of Support shown in Table 1.

<b>Last Date of Support: App. SW</b>	The last date to receive applicable service and support for the product as entitled by active service contracts or by warranty terms and conditions. After this date, all support services for the product are unavailable, and the product becomes obsolete.	March 31, 2016
