



End-of-Sale and End-of-Life Announcement for the Cisco TelePresence VX Clinical Assistant with Codec C20

Cisco announces the end-of-sale and end-of-life dates for the Cisco TelePresence VX Clinical Assistant with Codec C20. The last day to order the affected product(s) is June 17, 2013. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.

Cisco is scheduled to begin shipping version 1.2 of the VX Clinical Assistant at the end of January 2013. This release introduces a new model of the VX Clinical Assistant with the SX20 Quick Set codec, adding 1080p60 high-definition video and internal multisite capabilities. Please see the new part numbers in Table 2 below.
