

## End-of-Sale and End-of-Life Announcement for the Cisco TelePresence Management Server

Cisco announces the end-of-sale and end-of-life dates for the Cisco TelePresence Management Server. The last day to order the affected product(s) is February 3, 2012. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available until the termination date of the contract, even if this date exceeds the Last Date of Support shown in Table 1.

Please note this Product End-of-Life Notice does NOT apply to the Cisco TelePresence Management Suite (CTI-TMS-SW-K9) product offering. ONLY the server variant, Cisco TelePresence Management Server, has begun the End-of-Sale and End-of-Life process at Cisco.

<b>Last Ship Date: HW</b>	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	May 3, 2012

<b>End of Service Contract Renewal Date: HW</b>	The last date to extend or renew a service contract for the product.	April 30, 2016
<b>Last Date of Support: HW</b>	The last date to receive applicable service and support for the product as entitled by active service contracts or by warranty terms and conditions. After this date, all support services for the product are unavailable, and the product becomes obsolete.	February 28, 2017
