



## End-of-Sale and End-of-Life Announcement for the Cisco TelePresence Multipoint Switch

Cisco announces the end-of-sale and end-of-life dates for the Cisco TelePresence Multipoint Switch. The last day to order the affected product(s) is January 27, 2014. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.

<b>Last Date of Support: App. SW</b>	The last date to receive applicable service and support for the product as entitled by active service contracts or by warranty terms and conditions. After this date, all support services for the product are unavailable, and the product becomes obsolete.	January 31, 2017
