

End-of-Sale and End-of-Life Announcement for the Cisco 4-Port T1/E1 RJ-48 Circuit Emulation over IP and Serial Interface Network Modules

Cisco announces the end-of-sale and end-of life dates for the Cisco 4-Port T1/E1 RJ-48 Circuit Emulation over IP and Serial Interface Network Modules. The last day to order the affected product(s) is April 1, 2010. For customers with active and paid service and support contracts, support will be available until the termination date of the contract, even if this date exceeds the Last Date of Support shown in Table 1.
