

## End-of-Sale and End-of-Life Announcement for the Cisco Carrier Packet Transport (CPT) System Release 9.51 and 9.52 Software

Cisco announces the end-of-sale and end-of-life dates for the Cisco Carrier Packet Transport (CPT) System Release 9.51 and 9.52 Software. The last day to order the affected product(s) is March 16, 2015. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.
