Cisco announces the end-of-sale and end-of-life dates for the Cisco NCS1000 X.R. 7.0.0. SW. The last day to order the affected product(s) is November 13, 2020 . Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. End-of-Sale Date: OS SW,License	The last date to order the product through Cisco point-of-sale mechanisms. The product is no longer for sale after this date.	November 13, 2020
Last Ship Date: OS SW,License	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	February 12, 2021
End of SW Maintenance Releases Date: OS SW	The last date that Cisco Engineering may release any final software maintenance releases or bug fixes. After this date, Cisco Engineering will no longer develop, repair, maintain, or test the product software.	November 13, 2021
