

## End-of-Sale and End-of-Life Announcement for the Cisco ONS 15454 Miscellaneous Cables

Cisco announces the end-of-sale and end-of-life dates for the Cisco ONS 15454 Miscellaneous Cables. The last day to order the affected product(s) is May 12, 2012. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available until the termination date of the contract, even if this date exceeds the Last Date of Support shown in Table 1.

Several other cable lengths are still offered for sale. Only select cable lengths that have not sold in the last 18 months are being discontinued.

<b>Last Ship Date: HW</b>	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	August 10, 2012
<b>End of Routine Failure Analysis Date: HW</b>	The last-possible date a routine failure analysis may be performed to determine the cause of hardware product failure or defect.	May 12, 2013
