

# End-of-Sale and End-of-Life Announcement for the Cisco Connected Grid Module 1000 Series WiMax Modules

Cisco announces the end-of-sale and end-of life dates for the Cisco Connected Grid Module 1000 Series WiMax Modules. The last day to order the affected product(s) is February 24, 2018.
