



# End-of-Sale and End-of-Life Announcement for the Cisco GSR 12000 IOS Releases

Cisco announces the end-of-sale and end-of-life dates for the Cisco GSR 12000 IOS Releases. The last day to order the affected product(s) is April 30, 2013.
