### EOL13229

Cisco announces the end-of-sale and end-of-life dates for the Cisco Select ISRG2 Modules. The last day to order the affected product(s) is June 15, 2020. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin.
