

## Change in Product Part Number Announcement for the Cisco 2900 Series Integrated Services Routers Data Technology Package Licenses

Customers will continue to receive support from the Cisco Technical Assistance Center (TAC) until otherwise specified in the end-of-life announcement for the new product part numbers.
