



## End-of-Sale and End-of-Life Announcement for the Select Cisco 891 and 892 Integrated Services Routers

Cisco announces the end-of-sale and end-of-life dates for the Select Cisco 891 and 892 Integrated Services Routers. The last day to order the affected product(s) is July 3, 2014. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.
