Cisco announces the end-of-sale and end-of-life dates for the Cisco ASR1000 RP2-8GB memory and Miscellaneous Parts. The last day to order the affected product(s) is October 29, 2024. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Last Date of Support: HW	The last date to receive applicable service and support for the product as entitled by active service contracts or by warranty terms and conditions. After this date, all support services for the product are unavailable, and the product becomes obsolete.	October 31, 2029
