## Overview

### EOL15669

Cisco announces the end-of-sale and end-of-life dates for the Cisco ASR1006-X chassis. The last day to order the affected product(s) is July 31, 2026. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.

After the end-of-sale date indicated in this bulletin, there will be 3 years of support for vulnerability/security fixes with the last supported IOS XE software release. The last supported software release is IOS XE 17.18.

<b>End-of-Life Announcement Date</b>	The date the document that announces the end-of-sale and end-of-life of a product is distributed to the general public.	January 30, 2026

<b>Last Ship Date: HW</b>	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	October 29, 2026

<b>End of New Service Attachment Date: HW</b>	For equipment and software that is not covered by a service-and-support contract, this is the last date to order a new service-and-support contract or add the equipment and/or software to an existing service-and-support contract.	July 31, 2027

<b>End of Service Contract Renewal Date: HW</b>	The last date to extend or renew a service contract for the product.	October 26, 2030
<b>Last Date of Support: HW</b>	The last date to receive applicable service and support for the product as entitled by active service contracts or by warranty terms and conditions. After this date, all support services for the product are unavailable, and the product becomes obsolete.	July 31, 2031
